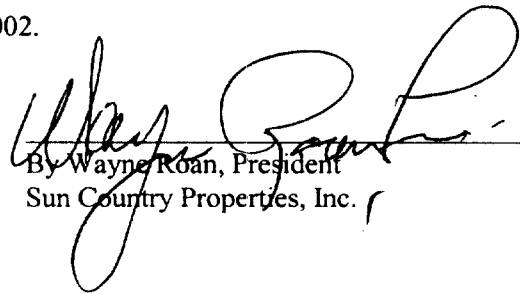

The true and actual consideration for this conveyance is other property or value given or promised.

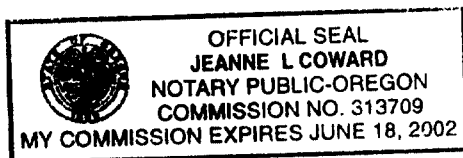

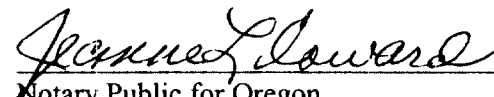
