ASSIGNMENT OF TRUST DEED

And the said party of the first part does hereby covenant to and with the said party of the second part, that the said party of the first part is lawful owner and holder of the said Installment Note and Trust Deed, and that they have good right to sell, transfer and assign the same as aforesaid, and that there is now due and owing upon the said Installment Note and Trust Deed the sum of Forty Two Thousand Four Hundred Six and 05/100 Dollars (\$42,406.05), with interest from the 1st day of May 2002.
