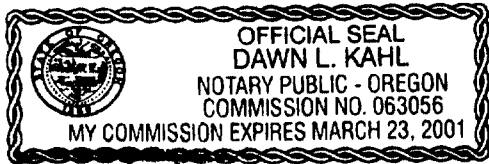

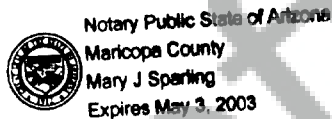

EXHIBIT "A"
DESCRIPTION OF PROPERTY

A tract of land situated in the SW ¼ of Section 18 and the NW ¼ of Section 19, all in Township 41 South, Range 13 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at the ¼ corner common to said Sections 18 and 19; thence N 00°08'16" E, along the North-South center section line of said Section 18, 984 feet, more or less, to a 5/8" iron pin with a Tru-Line Surveying plastic cap, from which the N ¼ corner of said Section 18 bears N 00°08'16" E 4332.68 feet; thence West 450.46 feet to a 5/8" iron pin with a Tru-Line Surveying plastic cap; thence North 250.00 feet to a 5/8" iron pin with a Tru-Line Surveying plastic cap; thence West 825.00 feet to a 5/8" iron pin with a Tru-Line Surveying plastic cap; thence South 300.00 feet to a 5/8" iron pin; thence West 720.00 feet to a 5/8" iron pin; thence North 720.00 feet; thence S 89°56'49" W 940.32 feet to a point 60.00 feet East of the West line of said Section 18; thence S 00°01'04" W, parallel to said Section line, 742 feet, more or less, to the center line of an irrigation canal; thence Southeasterly, along said canal center line, 3180 feet, more or less, to a point on the South line of the N ½ NW ¼ of said Section 19; thence East 900 feet, more or less to the CN 1/16 corner of said Section 19; thence Northerly 1348 feet, more or less, to the point of beginning.
