required to pay all expenses of maintaining the house and property, including utilities, repairs, and real property taxes.

- (2) I give the residue of my estate in equal shares to my two daughters, LOUISE BOWEN and BARBARA SCOTT.
- (3) If either of my daughters fails to survive me, I give such predeceased daughter's share of my estate to her issue who survive me, by right of representation. If there are no surviving issue, said predeceased daughter's share of my estate shall go to my surviving daughter.

### IV. PERSONAL REPRESENTATIVE

I appoint LAWRENCE SCOTT, currently residing in Dexter, Oregon, as personal representative of my estate, to serve without bond. If for any reason he cannot act, I appoint ROBIN SCOTT, as personal representative, to serve without bond.

I direct my personal representative to preserve, settle and distribute my estate in accordance with all lawful authority now or hereafter in effect including, but not limited to, the authority to prosecute any claim for wrongful death which is necessary for the protection of my estate.

If any beneficiary under this Will is a minor, my personal representative shall have the power, at his sole discretion, to distribute such beneficiaries' share pursuant to the Uniform Gift to Minors Act of the State of Oregon, or a
