## **RECITALS:**

RECITALS: Vivian N. Kimbol, as grantors, executed and delivered to: Aspen Title & Escrow, Inc., as trustee, for the benefit of Washington Mutual Bank, as beneficiary, a trust deed dated 11/22/96, duly recorded on 12/02/96 in the mortgage records of Klamath County, Oregon in Vol. M96 Page 37554.
