## **DESCRIPTION**

The following described real property situate in Klamath County, Oregon:

A tract of land situated in the N½ of Section 20, Township 39 South, Range 11½ East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at a point on the South line of the N ½ of said Section 20, said point being South 89°16'53" West a distance of 3322.85 feet from the East quarter corner of said Section 20; thence South 89°16'53" West 627.06 feet to the Southwest corner of the SE ¼ NW ¼ of said Section 20; and the true point of beginning of this description; thence North 00°48'38" West along the West line of the SE ¼ NW ¼ of said Section 20, 649.47 feet; thence North 40°24'01" East 664.38 feet to the Southwesterly right of way line of the County Road; thence Northwesterly along the South line of said road to the Easterly line of the NW ¼ of said Section 20; thence along the Easterly line of the W ½ of the NW ¼ to the true point of beginning.

ALSO the SW ¼ of the NW ¼ of Section 20, Township 39 South, Range 11 ½ East of the Willamette Meridian, Klamath County, Oregon.

EXCEPTING THEREFROM a tract of land in the N ½ of Section 20, Township 39 South, Range 11 ½ East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Commencing at the Southwest corner of the SE ¼ NW ¼ of said Section 20, said corner being South 89°16′53″ West A Distance of 3949.91 feet from the East quarter corner of said Section 20; thence North 00°48′38″ West 649.47 feet Along the West line of the SE ¼ NW ¼ of said Section 20; thence North 40°24′01″ East, 664.38 feet to the Southwesterly right of way line of North Poe Valley Road; thence Northwesterly along the South line of said Road to its intersection with a line 200 feet distant from and parallel with the last mentioned course, said point being The true point of beginning of this description; thence South 40°24′01″ West, 236.7 feet more or less along said Parallel line to the Northerly right of way line of the K.I.D. "E" Canal; thence Northwesterly along said right of way Line to its intersection with the South line of the NW ¼ NW ¼ of said Section 20; thence Easterly along said South Line to the Southeast corner of said NW ¼ NW ¼; thence North 00°48′38″ West along the East line of said NW ¼ NW ¼ to the Southwesterly right of way of North Poe Valley Road; thence Southeasterly along said right of way to The true point of beginning.
