QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Town of Bonanza hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

A tract of land located in the South one half of the Southwest quarter of the Northwest quarter (S $\frac{1}{2}$  SW $\frac{1}{4}$  NW $\frac{1}{4}$ ) of Section 10, Township 39 South, Range 11 East, Willamette Meridian, Klamath County, Oregon, more particularly described as follows: Beginning at the Northwest corner of the S $\frac{1}{2}$  SW $\frac{1}{4}$  NW $\frac{1}{4}$  of said Section 10; thence S 00° 20' 00" E along the West boundary of Section 10, 12.10 feet to the North boundary of High Street in the subdivision plat of Grandview Addition To The Town Of Bonanza; thence East, along the North boundary of High Street to the East boundary of the SW $\frac{1}{4}$  NW $\frac{1}{4}$  of said Section 10; thence North, along the East boundary of the SW $\frac{1}{4}$  NW $\frac{1}{4}$  to the Northeast corner of the S $\frac{1}{2}$  SW $\frac{1}{4}$  NW $\frac{1}{4}$ ; thence N 89° 54' 41" W along the North boundary of the S $\frac{1}{2}$  SW $\frac{1}{4}$  NW $\frac{1}{4}$  to the point of beginning.

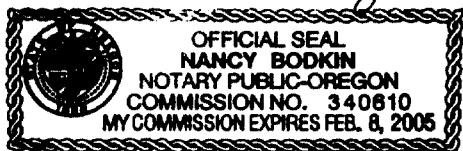
