Sale Agreement with Nicholas M. Sinkewitsch*)

Order No. 2003 - 021

WHEREAS, Nicholas M. Sinkewitsch entered into an agreement with Klamath County on June 7, 2001, for the purchase of real property described as:

The North 415 feet of the East 1000 feet of Lot 18, Block 18, Klamath Falls Forest Estates Sycan Unit, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

SUBJECT TO Covenants, conditions, reservations, easements, restrictions, rights, rights of way and all matters appearing of record.

WHEREAS, the above real property was purchased for the sum of \$3,050.00 and a down payment of \$762.50 was made June 7, 2001; and

WHEREAS, Nicholas M. Sinkewitsch failed to make the June 7, 2002, annual installment as required by Section 2 of the Land Sale Agreement. The installment is now in default under the terms of the Land Sale Agreement; and

WHEREAS, on June 24, 2002, a letter was mailed regular and certified to Nicholas M. Sinkewitsch requesting the annual installment in the amount of \$1,022.59 be paid in full by July 26, 2002. A return receipt to Klamath County Property Sales Department was received on July 9, 2002; and

WHEREAS, a final notice was mailed regular and certified on August 1, 2002, requesting the remaining balance, interest and recording fee in the amount of \$2,576.11 be paid by August 8, 2002; and

WHEREAS, no payment has been made and the Land Sale Agreement is now in **Default**.


NOW, THEREFORE, IT IS HEREBY ORDERED, that the Land Sale Agreement between Klamath County and Nicholas M. Sinkewitsch dated June 7, 2001, is hereby cancelled. A certified copy of this Order shall be served as summons is served by the Sheriff to Nicholas M. Sinkewitsch




NOTE: Pursuant to ORS 275.220 (2) within twenty (20) days after the service of the order of cancellation upon the holder, the holder of the canceled contract may appeal from such order to the circuit court for the county in which the land is located. The appeal shall be tried by the court as an action not triable by right to a jury. If appeal is not so taken or if it results upon trial in an affirmance of the order of cancellation, such order shall become absolute and the real property so forfeited again may be sold, without notice.




