SUPPLEMENT TO DECLARATION OF PROTECTIVE COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR RUNNING Y RANCH RESORT

(Consolidation of Lots)

THIS SUPPLEMENT TO DECLARATION OF PROTECTIVE COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR RUNNING Y RANCH RESORT (this "Consolidation Declaration") is dated as of September 17", 2002 (the "Effective Date"), by RUNNING Y RESORT, INC., an Oregon corporation ("Declarant"), in favor of the owner of Lots 247 and 265, plat of Running Y Resort Phase 3, Klamath County, Oregon (the "Owner").

- B. By Declaration Annexing Phase 3 of Ridge View Homesites to Running Y Ranch Resort, recorded July 25, 1997, in Volume M97, Page 23691 in the Records of Klamath County, Oregon, Declarant caused certain lots within the plat of Running Y Resort Phase 3, Klamath County, Oregon to be annexed to the Declaration and made subject to the terms thereof, including Lot 247 and Lot 265, collectively the "Adjoining Lots".
