Subordination Agreement

THIS SUBORDINATION AGREEMENT ("Agreement") is made this 24 September, 2002, by The Chase Manhattan Bank as Indenture Trustee, Residential Funding Corporation, Attorney in Fact ("Subordinating Lender").
