DEED IN LIEU OF FORECLOSURE, SATISFACTION

KNOW ALL MEN BY THESE PRESENTS, that Christine E. Abbey, hereinafter called Grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto Wayne P. Snoozy and Sharon E. Snoozy, hereinafter called Grantee, and unto Grantee's successor and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereto belonging or in any way appertaining, situated in the County of Klamath, State of Oregon, described as follows:

Lot 2 in Block 57 of Second Addition to Hot Springs,
according to the official plat thereof on file in the office of
the County Clerk of Klamath County, Oregon.

To have and to hold the same unto the said Grantee and Grantee's successors and assigns forever.

This deed is absolute in effect and conveys fee simple title of the premises above described to the Grantee and does not operate as a mortgage, trust conveyance, or security of any kind.

The actual consideration consists of other property or value given or promised, which is the whole considerations (further described below).

This deed does not effect a merger of the fee ownership and the lien of the trust deed described below. The fee and lien shall hereafter remain separate and distinct.

By acceptance of this deed, Grantee covenants and agrees that it shall forever forbear taking any action whatsoever to collect against Grantor on the promissory note which is secured by the trust deed below, other than by foreclosure of that trust deed, and that in any proceeding to foreclose that trust deed it shall not seek or obtain a deficiency judgment against Grantor, his heirs or assigns, such rights and remedies being hereby waived.

Grantor does hereby waive, surrender, convey and relinquish any equity of redemption and statutory rights of redemption concerning the real property and the trust deed described below.

Grantor is not acting under any misapprehension as to the legal effect of this deed, nor under any duress, undue influence or misrepresentation of Grantee, its agent, attorney or any other person.

The true and actual consideration for this transfer consists of Grantee's waiver of its rights, if any, to a deficiency judgment and Grantee's agreement not to name, except as necessary to clear title, the Grantor as a party to a foreclosure action as stated above with respect to that certain trust deed or mortgage entered into June 29, 2001, between Grantor and Wayne P. Snoozy and Sharon E. Snoozy, and recorded in Volume M01, page 31771, re-recorded June 29, 2001 in Volume m01, page 33107, Microfilm Records of Klamath County, Oregon. Said trust deed or mortgage was given to secure a note between Grantor and Grantee in the amount of \$ 22,000. Grantor states that the consideration for this deed, described above, is reasonably equivalent in value to the Grantor's interest in the property described above.

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.

THIS INSTRUMENT WILL NOT ALLOW USE OF THE PROPERTY DESCRIBED IN THIS INSTRUMENT IN VIOLATION OF APPLICABLE LAND USE LAWS AND REGULATIONS. BEFORE SIGNING OR ACCEPTING THIS INSTRUMENT, THE PERSON ACQUIRING FEE TITLE TO THE PROPERTY SHOULD CHECK WITH THE APPROPRIATE CITY OR COUNTY PLANNING DEPARTMENT TO VERIFY APPROVED USES.

Acceptance of this deed by Grantee is conditioned upon Grantee's determination that the title to the real property is not encumbered by any liens, encumbrances or interests of any parties, excepting Grantor, which are subject and inferior to the lien of the trust deed described above, as of the date this deed is

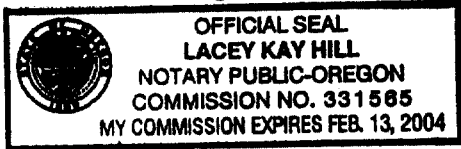
presented for recording in the official records of the county in which the described real property is located.
