KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon

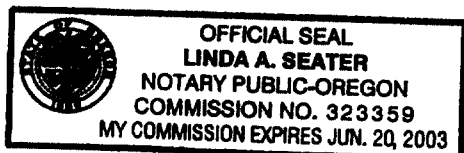
