KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Edward Louis Oueilhe & Deborah L. Oueilhe, Trustees of the Oueilhe Family Trust, dated March 25, 1995 hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

Lot 43, Block 24, Tract 1113 - Oregon Shores - Unit 2 situated in Section 18, Township 35 South, Range 7 East of the Willamette Meridian, Klamath County, Oregon.

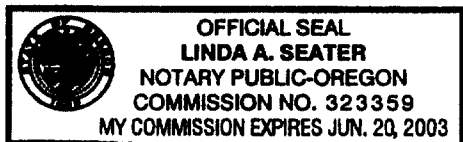
