

KNOW ALL MEN BY THESE PRESENTS, That John Carter and Frances Louise Carter, husband and wife, hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and quitclaim unto Mary N. Sutton, hereinafter called grantee, and unto Grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any-wise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

A portion of land in the E 1/2 of the NE 1/4 of Section 19, Township 28 South, Range 8 East of the Willamette Meridian, shown as Parcel No. 2 on Map of Survey No. 1343, filed in the office of the Klamath County Surveyor, Klamath Falls, Oregon, described as follows:
