Lots 12 and 13, in Block 3, in Tract 1069, LITTLE DESCHUTES RIVER WOODS, Klamath County, Oregon.-----

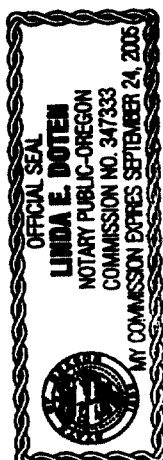
