## KS8835 TRUSTEE'S DEED

## **RECITALS:**

RECITALS: Wayne H. Westlund, a married person, as grantors, executed and delivered to: Amerititle, as trustee, for the benefit of Norwest Mortgage, Inc., as beneficiary, a trust deed dated 07/09/96, duly recorded on 07/16/96 in the mortgage records of Klamath County, Oregon in Volume M96, Page 21199 and subsequently assigned to Oregon Housing Authority and Community Services Department by Assignment recorded as Volume M96, Page 21209. In the trust deed, the real property described below ("Property") was conveyed by the grantor to the trustee to secure, among other things, the performance of the grantor's obligations to the beneficiary. If the foreclosure was stayed and released from stay, copies of an Amended Notice of Sale in the form required by ORS 86.755(6) were mailed within thirty days after release from stay by registered or certified mail to the last-known address of those persons listed in ORS 86.740 and 86.750(1) and any person requesting notice who was present at the time and place set for the sale which was stayed. Further, the trustee published a copy of the Trustee's Notice of Sale in a newspaper of general circulation in each county in which the Property is located, once a week for four successive weeks; the last publication of Notice of Trustee's Sale occurred more than twenty days prior to the date of sale. The mailing, service and publication of the Trustee's Notice of Sale are evidenced by one or more affidavits or proofs of service duly recorded prior to the date of sale in the official records of the county in which the Property is located.
