KNOW ALL BY THESE PRESENTS that Robert R. Hall

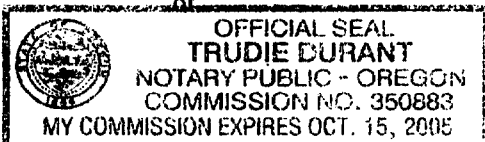
