


RECONVEYANCE

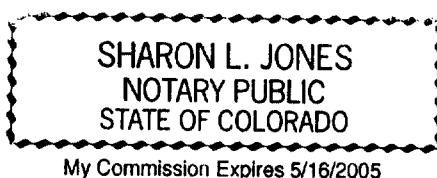

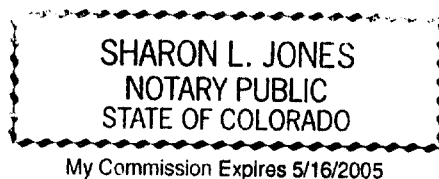
