600 Hillside Ave, Klamath Falls, Oregon 97601.

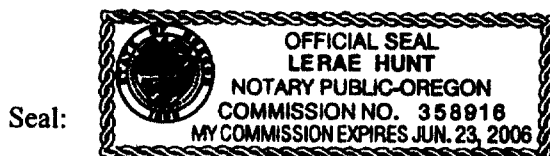
