## EXHIBIT "A" DESCRIPTION OF PROPERTY

## PARCEL ONE:

Government Lots 20, 21, 28 and 29, Section 32, Township 35 South, Range 7 East of the Willamette Meridian, in the County of Klamath, State of Oregon.
