**EXHIBIT "A"**  
**LEGAL DESCRIPTION**

All of that portion of the NW1/4 of the SE1/4 of Section 17, Township 28South, Range 8 East of the Willamette Meridian, Klamath County, Oregon, lying on the Westerly side of the Southern Pacific Railroad right of way, EXCEPTINGTHEREFROM the following:

Commencing at the Northwest corner of the NW1/4 of the SE1/4 of Section 17, Township 28 South Range 8 East of the Willamette Meridian; thence East 368 feet to the Southern Pacific Railroad right of way; thence South 10 degrees West 196 feet to the North boundary of the Silver Lake Road; thence North 68 degrees West 350.5 feet along the Northerly right of way boundary of the Silver Lake Road to the West line of the said NW1/4 of the SE1/4 of Section 17; thence North 57 feet to the point of beginning.

ALSO EXCEPTING THEREFROM all mineral of every kind as reserved in Deed dated May 7, 1959 and recorded May 25, 1959 in Volume 312, page 609, Deed Records of Klamath County, Oregon.

ALSO EXCEPTING THEREFROM any portion lying within existing roadways.
