

TRUSTEE'S NOTICE OF SALE

Reference is made to that certain Trust Deed made by ANDREI MIKHALEV, as Grantor to Amerititle, Inc., as Trustee in favor of RUNNING Y RESORT, INC., an Oregon corporation, as beneficiary, dated February 5, 2000 and recorded, February 18, 2000, in Volume M00 at Page 5274 Records of Klamath County, Oregon, covering the following described real property in said county and state: Lot 262 of Running Y Resort, Phase 3, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Both the beneficiary and the trustee have elected to sell the said real property to satisfy the obligations secured by said Trust Deed and a Notice of Default has been recorded pursuant to Oregon Revised Statutes, the default for which foreclosure is made is grantor's failure to pay, when due, the following sums:
