A. VALERIE JEAN CRAIN, NKA VALERIE JEAN JONES, Grantor, executed and delivered to WILLIAM L. SISEMORE, Trustee for the benefit of KLAMATH FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, Beneficiary, a Trust Deed dated October 5, 1999 and recorded on October 6, 1999, in the Official Records of Klamath County, Oregon as Volume M99, Page 39860 (the Trust Deed).
