TRUSTEE'S DEED

THIS INDENTURE, Made on January 13, 2003, between Dennis Fennell, hereinafter called trustee, and Harold Elliot, hereinafter called the second party.

Reference is made to that certain Deed of Trust dated June 21, 1995, recorded June 26, 1995, in Book M-95, Page 16605, in the records of Klamath County, Oregon, between Grantor Roy Harris and Debra J. Harris, husband and wife, Trustee Bend Title Company, an Oregon Corporation, and Beneficiary Harold Elliot, concerning the below described real estate:

A copy of the notice of sale was mailed by first class and certified mail with return receipt requested to the last known address of the guardian, conservator or administrator or executor of any person named in ORCP 86.740(1), promptly after the trustee received knowledge of the disability, insanity or death of any such person. The trustee published a copy of the notice of sale in a newspaper of general circulation in each county in which the real property is situated once a week for four successive weeks. The last publication of the notice occurred more than 20 days prior to the date of sale. The mailing, service and publication of the notice of sale are shown by affidavits and/or proofs of service duly recorded prior to the date of sale in the county records, those affidavits and proofs, together with the Notice of Default and Election to Sell and the Notice of Sale, being now referred to and incorporated in and made a part of this deed as if fully set forth herein. The undersigned trustee has no actual notice of any person, other than the persons named in those affidavits and proofs as having or claiming a lien on or interest in the real property, entitled to notice pursuant to ORS 86.;740(1)(b) or (1)(c).
