MEMORANDUM OF ASSUMPTION AND NOVATION OF A TRUST DEED
(For Replacement Property Lender Financing
"Reverse Starter" With Back-end Exchange - 02-0606)

A. Reference is made to that certain Deed of Trust (the 'Trust Deed') dated Aug. 12, 2002, recorded Aug. 19, 2002 as Instrument No. Vol. M02 P. 46589, in the Official Records of Klamath County, between American Exchange Services, Inc., as Grantor and Scott Valley Bank, as Beneficiary and First American Title as Trustee;

B. Reference is also made to that certain Novation and Release Agreement (the 'Novation and Release Agreement') dated 6-19-2002 between Grantor, Beneficiary and West Main Investments LLC, as Exchanger.

AGREEMENT:

1. This is to certify that effective as of the date hereof, pursuant to the Novation and Release Agreement:

(a) All right, title, interest, liability and obligation of Grantor under the Trust Deed and the promissory note secured by the Trust Deed has been assigned to and assumed by the Exchanger.

(b) Exchanger has assumed sole obligation in the place and stead of American Exchange Services, Inc. as the Grantor of the Trust Deed (and as the obligor of the promissory note secured by the Trust Deed); and

(c) American Exchange Services, Inc. has been released from all liability and obligation under the Trust Deed and the promissory note secured by the Trust Deed.

2. The above mentioned assignment to, assumption by and substitution of Exchanger by, from and for American Exchange Services, Inc. and the above mentioned release of American Exchange Services Inc by Beneficiary constitute a novation.

3. Reference is hereby made to the Novation and Release Agreement for all matters and things therein contained.

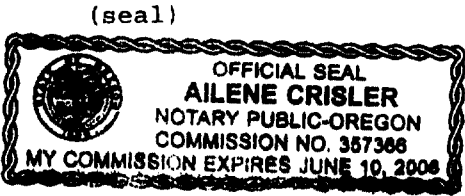
