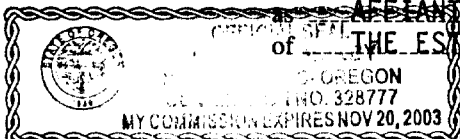

EXHIBIT "A"
LEGAL DESCRIPTION

A tract of land situated in the NE1/4 SE1/4 of Section 12, Township 39 South, Range 8 East, Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at a ½ inch iron pin on the East right of way line of Orindale Road, said point being South 1° 18' West a distance of 154.55 feet and East a distance of 30.00 feet from the Northwest corner of the NE1/4 SE1/4 of said Section 12; thence East a distance of 353.86 feet to a ½ inch iron pin; thence North 1° 18' East a distance of 117.52 feet to a ½ inch iron pin on the South right of way line of Balsam Drive; thence North 88° 57' West along said South line of Balsam Drive a distance of 353.77 feet to a ½ inch iron pin on said East line of Orindale Road; thence South 1° 18' West along said East line of Orindale Road a distance of 124.00 feet to the point of beginning.
