RICHARD L. BIGGS, SUCCESSOR TRUSTEE, HEREBY GIVES NOTICE OF DEFAULT AND ELECTION TO SELL:

Reference is made to that certain trust deed made by Connic L. Perkins, as grantor, to Aspen Title, as trustee, in favor of CitiFinancial, Inc., as beneficiary, dated January 24, 2002, recorded January 25, 2002, in the mortgage records of Klamath County, Oregon, as Vol M02, page 4948, covering the following described real property situated in the above-mentioned county and state, to-wit:
