WARRANTY DEED

KNOW ALL BY THESE PRESENTS that JAMES REDD & SHARON E. REDD, as tenants by the entirety

hereinafter called grantee, does hereby grant, bargain, sell and convey unto the grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

Parcel 2 of Land Partition 57-93, said Land Partition situated in the SE1/4 NE1/4 of Section 35 and the SW1/4 NW1/4 of Section 36, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon.
