R-3407-034CA-02700 - All that portion of Lot 6, Section 34, Township 34 South, Range 7 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows: Beginning at a point bearing North 47° 12' West 700 feet and North 30° 30' East, 10.2 feet from the intersection of the Westerly line of Lalakes Avenue with the Northerly line of Chocktoot Street in the Townsite of West Chiloquin; thence North 47° 12' West parallel and distant 10 feet from the county road, 60 feet; thence North 30°30' East parallel to Lalakes Avenue, 120 feet; thence South 47° 12' East, 60 feet; thence South 30° 30' West, 120 feet to the point of beginning.
