## BARGAIN AND SALE DEED

KNOW ALL BY THESE PRESENTS that Joe A. Jones

## Parcel 1:

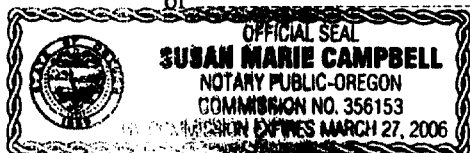
