ALSO, a portion of Section 34, Township 35 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon, being more particularly described as follows:

Beginning at the Southwest corner of the N $\frac{1}{2}$ SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 34, Township 35 South, Range 10 East of the Willamette Meridian, thence Southerly along the West line of Section 34 to the Southwest corner of the SW $\frac{1}{4}$; thence Easterly along the South line of Section 34 to the Southeast corner of the SW $\frac{1}{4}$; thence Northerly along the East line of the SW $\frac{1}{4}$ to the Northeast corner of the S $\frac{1}{4}$ SW $\frac{1}{4}$; thence diagonally Northwesterly to the point of beginning.
