Wagner agree to sell and Dale Leix agrees to buy Lot 35 Block 14 Hwy 66 Plat #1 of Klamath Falls Forest Estates in Klamath County, Oregon for the price of \$11,000.00 (eleven thousand dollars). Dale Leix agrees to pay \$2000.00 down payment, of which \$1000.00 will be paid by December 2002. Monthly payments will be at least \$120.00 but they may be more according to the desire of the buyer. The first monthly payment will be due May 15, 2002 and monthly payments will be due on the fifteenth day of each month thereafter until the balance is completely paid. The balance can be completely paid at any time with no pre-payment penalty. The buyer will pay the property taxes in November 2002 and each year thereafter. Interest on the balance will be at the rate of 9% per year (0.75% per month). When the lot is fully paid a deed will be executed for the buyer.
