## TRUSTEE'S DEED

THIS INDENTURE, made this 20th day of March, 2003, between Northwest Trustee Services, PLLC, hereinafter called the Trustee and William S. Cantrell, hereinafter called the second party;

## **RECITALS:**

RECITALS: David A. McCanna, a married person, Mary L. McCanna, a married person, as grantors, executed and delivered to: First American Title Insurance Company, as trustee, for the benefit of U.S. Bank, National Association, as beneficiary, a trust deed dated 03/28/00, duly recorded on 03/31/00 in the mortgage records of Klamath County, Oregon in Volume M00, Page 10702 and subsequently assigned to Cendant Mortgage Corporation by Assignment recorded as Volume M00, Page 33242. In the trust deed, the real property described below ("Property") was conveyed by the grantor to the trustee to secure, among other things, the performance of the grantor's obligations to the beneficiary. The grantor thereafter defaulted in the performance of those obligations and such default(s) still existed at the time of the trustee's sale of the Property described below.

Because of the default(s), the record beneficiary under the trust deed or its predecessor declared all sums secured by the trust deed immediately due and owing; therefore, a Notice of Default, containing an election to sell the Property and to foreclose the trust deed by advertisement and sale to satisfy grantor's obligations owed to the beneficiary was recorded in the mortgage records of the county in which the Property is located on 10/31/02, in Volume M02 Page 62987.

If the foreclosure was stayed and released from stay, copies of an Amended Notice of Sale in the form required by ORS 86.755(6) were mailed within thirty days after release from stay by registered or certified mail to the last-known address of those persons listed in ORS 86.740 and 86.750(1) and any person requesting notice who was present at the time and place set for the sale which was stayed. Further, the trustee published a copy of the Trustee's Notice of Sale in a newspaper of general circulation in each county in which the Property is located, once a week for four successive weeks; the last publication of Notice of Trustee's Sale occurred more than twenty days prior to the date of sale. The mailing, service and publication of the Trustee's Notice of Sale are evidenced by one or more affidavits or proofs of service duly recorded prior to the date of sale in the official records of the county in which the Property is located.
