BARGAIN AND SALE DEED

KNOW ALL BY THESE PRESENTS that JEAN ANNE GREGGhereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto
JEAN ANNE GREGG-MYRICKhereinafter called grantee, and unto grantee's heirs, successors and assigns, all of that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in KLAMATH County, State of Oregon, described as follows, to-wit:

Beginning at the center of Section 12, Township 39 South, Range 8 East of the Willamette Meridian, in the County of Klamath, State of Oregon; thence North 690 feet; thence North 89° degrees 49' West for a distance of 690 feet; thence North 89 degrees 49' West 300 feet; thence South 600 feet; thence South 89 degrees 49' East for a distance of 300 feet to the point of beginning.

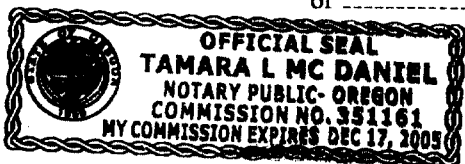
