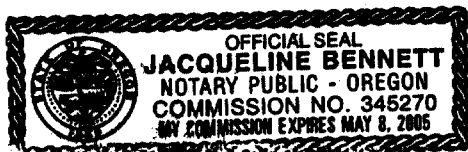

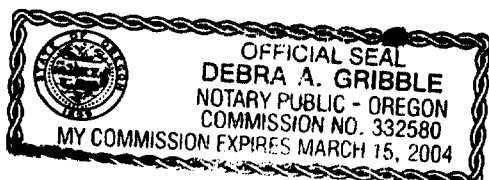

NOTICE OF DEFAULT AND ELECTION TO SELL

Reference is made to that certain trust deed made by WILLIAM ALLEN BLOSS and EMILY OLGA BLOSS, as Tenants by the Entirety, as grantor, to AMERITITLE, INC., as trustee, in favor of LILY SIOU and SHANNON SIOU, with right of survivorship, as beneficiary, dated August 7, 2001, recorded August 15, 2001, in the mortgage records of Klamath County, Oregon, in book/reel/volume No. M01 at page 41176, covering the following described real property situated in said county and state, to-wit:

Lot 1 in Block 2 of WILLIAMS ADDITION TO THE CITY OF KLAMATH FALLS, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, AND that portion of the vacated alley lying between Lot 1 and the U.S. Bureau of Reclamation "A" Canal.

Both the beneficiary and the trustee have elected to sell the said real property to satisfy the obligations secured by said trust deed and a Notice of Default has been recorded pursuant to Section 86.735(3) of Oregon Revised Statutes. WHEREFORE, notice hereby is given that the undersigned trustee will on April 7, 2003 at the hour of 10:00 AM Standard time, as established by Section 187.110, Oregon Revised Statutes, at 280 Main Street, in the City of Klamath Falls, County of Klamath, State of Oregon, sell at public auction to the highest bidder for cash the interest in said described real property which the grantors had or had power to convey

at the time of the execution by him of said trust deed, to satisfy the foregoing obligations thereby secured and the costs or their successors in interest acquired after the execution of said trust deed, to satisfy the foregoing obligations thereby secured and the costs and expenses of sale, including a reasonable charge by the trustee.
