# SECOND AMENDMENT TO LINE OF CREDIT DEED OF TRUST, SECURITY AGRÉEMENT, FINANCING STATEMENT, FIXTURE FILING AND ASSIGNMENT OF RENTS AND LEASES

THIS SECOND AMENDMENT TO DEED OF TRUST, SECURITY AGREEMENT, FINANCING STATEMENT, FIXTURE FILING AND ASSIGNMENT OF RENTS AND LEASES ("Second Amendment") is entered into as of the 21st day of February, 2003 by and among U. S. TIMBERLANDS YAKIMA, LLC, a Delaware limited liability company, having its principal place of business at 700 East Mountain View, Suite 507, Ellensburg, Washington 98926 ("Grantor"), Chicago Title Insurance Company, whose address is 10001 S. E. Sunnyside Road, Clackamas, Oregon 97015, as Trustee ("Trustee"), in trust for the benefit of BNY MIDWEST TRUST COMPANY, an Illinois corporation, having an address at 2 North LaSalle Street, Suite 1020, Chicago, Illinois 60602 ("Beneficiary") acting as trustee under the Indenture, and MBIA Insurance Corporation, having an address at 113 King Street, Armonk, New York 10504, as insurer ("Insurer"). Capitalized terms used herein but not defined herein shall have the meanings ascribed to such terms in the Original Deed of Trust (as such term is defined below).

### WITNESSETH:

WHEREAS, Grantor has issued certain notes in one or more series, the initial series having an aggregate face value not to exceed NINETY FIVE MILLION AND NO/100THS DOLLARS (\$95,000,000.00) and maturing in no event later than September 14, 2015, pursuant to that certain U. S. Timberlands Yakima Indenture, dated September 14, 2001, by and among Grantor, Insurer and Beneficiary, and any applicable Supplement dated of even date therewith or such other later date (the "Original Indenture").

WHEREAS, in order to secure the payment and performance by Grantor of the Secured Obligations of the Original Indenture, Grantor granted and Trustee, on behalf of the Secured Parties, accepted a lien upon, security interest in, and an assignment of certain Mortgaged Property owned by Grantor as evidenced by that certain Line of Credit Deed of Trust, Security Agreement, Financing Statement, Fixture Filing and assignment of Rents and Leases dated as of September 14, 2001 and recorded September 14, 2001 in Volume M01, Page 46920, in the records of Klamath County, Oregon and by that certain First Amendment to Line of Credit Deed of Trust, Security Agreement, Financing Statement, Fixture Filing and assignment of Rents and Leases dated as of February 16, 2003 and recorded February 24, 2003 in Volume ma3, Page 11028, in the records of Klamath County, Oregon, each by and among Grantor, Trustee and Insurer and collectively referred to as the "Original Deed of Trust".

WHEREAS, Grantor intends to issue certain notes in one or more series, the second series having an aggregate face value not to exceed THIRTY TWO MILLION AND NO/100THS DOLLARS (\$32,000,000.00) and maturing in no event later than September 14, 2015 (the notes of the initial series referenced above, the second series, and all subsequent series hereinafter referred to as the "Notes"), pursuant to the Original Indenture, as amended by that certain Amendment No. 3, dated as of February 25, 2003, by and among Grantor, Insurer and Beneficiary, and any applicable Supplement dated as of the date of Amendment No. 3 or such other later date (such Original Indenture as amended by Amendment No. 3, the "Indenture").

WHEREAS, Grantor has acquired certain real property, commonly referred to as the "Camp 6 Tract," the "Chemult Tract," and the "Mitchell Tract", by Warranty Deed (Camp 6 Tract) dated as of December 20, 2002 and recorded December 30, 2002 in Volume M02, Page 76209, by Warranty Deed (approximately ½ of the Chemult Tract) dated as of December 20, 2002 and recorded December 30, 2002 in Volume M02, Page 76224, and by Warranty Deed (remaining portion of the Chemult Tract and the Mitchell Tract) dated as of February 18/2, 2003 and recorded February 18/2, 2003 in Volume 18/2, Page 18/2, all in the records of Klamath County, Oregon, as further described in Section 1 below and referred to as the "Additional Property".

WHEREAS, It is the intention of the Grantor, Beneficiary and Insurer that the Additional Property be subject to the lien of the Original Deed of Trust.

#### **AGREEMENT**

NOW, THEREFORE, for and in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

- 1. Additional Property. Exhibit A of the Original Deed of Trust is hereby amended to include all property described on Schedule A attached hereto and by this reference incorporated herein (the "Additional Property"). All references to "Exhibit A" and "Timber Property" in the Original Deed of Trust shall hereafter include the Additional Property described in this Amendment as if such property had been included in the Original Deed of Trust as of the date of execution thereof.
- 2. <u>Permitted Exceptions</u>. Exhibit B of the Original Deed of Trust is hereby amended to include the following language as subsection (k) thereof

"The specific matters, if any, to which the Timber Property in Klamath County, Oregon, is expressly made subject as set forth in the Commitments for Title Insurance issued by Chicago Title Insurance Company as Order No. 59432, effective as of November 27, 2002 and Order No. 59571, effective as of January 13, 2003.

- 3. Ratification. The Original Deed of Trust, as amended and supplemented by this Second Amendment, is hereby ratified and affirmed and remains in full force and effect. It is not the intent of the parties hereto that the lien of the Original Deed of Trust be released, reconveyed or interrupted; but, rather, that the lien be continued uninterrupted and in full force and effect on the terms as provided in the Original Deed of Trust and herein and with the same priority as the Original Deed of Trust had prior to the date hereof.
- 4. <u>Deed of Trust</u>. All references to the "Deed of Trust" shall hereafter refer to the Original Deed of Trust as amended and supplemented by this Second Amendment.
