Beginning at a point on the Southerly line of the SW1/4 NW1/4, 210 feet East of the Southeast corner of Summers Heights; thence North 30 feet; thence West 10 feet; thence North 90 feet; thence East to the Westerly line of U.S.B.R. A-3-D Lateral; thence South along said Westerly line to the Southerly line of said SW1/4 NW1/4; thence Westerly along said Southerly line to the point of beginning.
