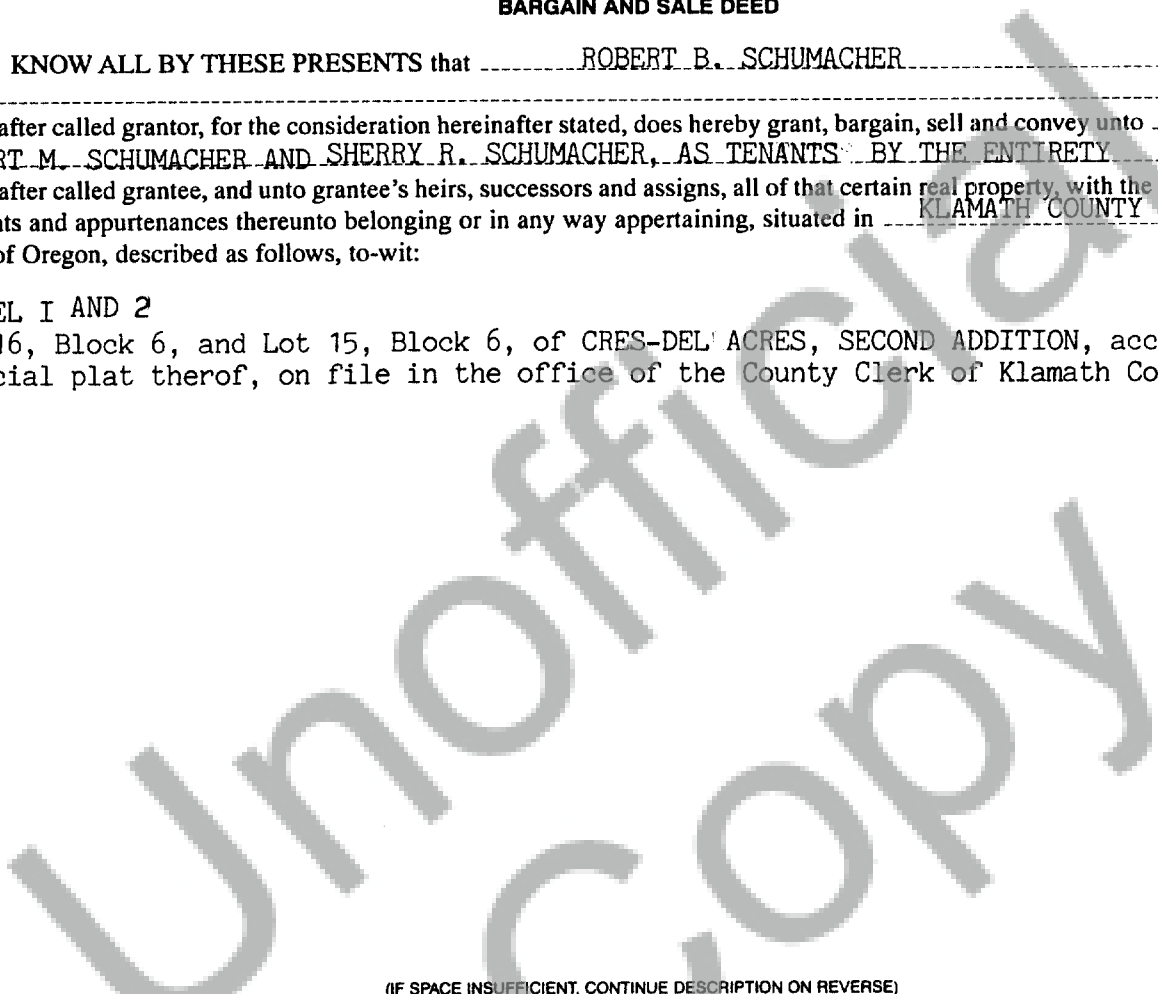
BARGAIN AND SALE DEED

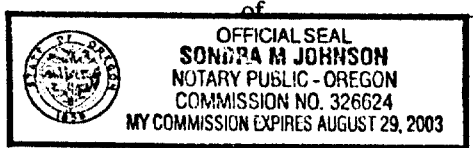
