(b) on the date I am adjudged incompetent by a court of proper jurisdiction.

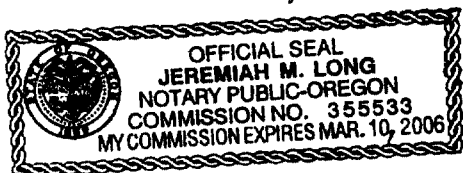
