

ASSIGNMENT OF TRUST DEED BY BENEFICIARY OR BENEFICIARY'S SUCCESSOR IN INTEREST

FOR VALUE RECEIVED, The undersigned who is the beneficiary or beneficiary's successor in interest under that certain trust deed dated January 23, 1992 executed and delivered by Robert R. Rider and Edythe Rider, husband and wife, grantor, to Mountain Title Company of Klamath County, Trustee, in which Ida Cabitto and Donald L. Cabitto, Jr. is the beneficiary, recorded on January 29, 1992 in Volume M92, page 1944, and re-recorded in Volume M92, page 4537 of the Official Records of Klamath County, Oregon and conveying real property in that county described as follows:

hereby grants, assigns, transfers, and sets over to State National Bank of Garfield, hereinafter called assignee, and assignee's heirs, personal representatives, successors and assigns, all of the beneficial interest in and under the trust deed, together with the notes, moneys and obligations therein described or referred to, with the interest thereon, and all rights and benefits whatsoever accrued or to accrue under said trust deed.

The undersigned hereby covenants to and with the assignee that the undersigned is the beneficiary or beneficiary's successor in interest under the trust deed and is the owner and holder of the beneficial interest therein and has the right to sell, transfer and assign the same, and the note or other obligation secured thereby. There is now unpaid on the obligations secured by the trust deed and sum of not less than \$38,740.18 with interest thereon at the rate of 8 percent per annum from October 3, 2002.

In construing this instrument, and whenever the context so requires, the singular includes the plural.

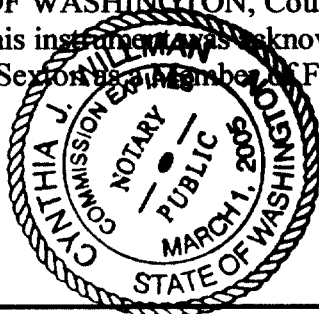
