A parcel of land, situated in the W 1/2 NE 1/4 NW 1/4 of Section 10, Township 39 South, Range 9 East, W.M., Klamath County Oregon, being a portion of Parcel 3 of Land Partition 8-98, according to the official plat thereof on file in the office of the Klamath County Clerk and being more particularly described as follows:

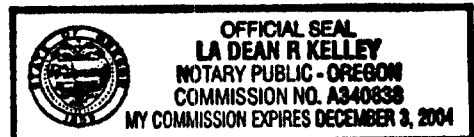

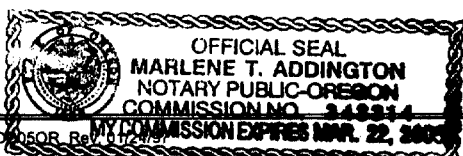
