EXHIBIT "A" LEGAL DESCRIPTION

The following described parcel of real property situated in Klamath County, Oregon, and being a portion of Tracts 3 and 4, DE WITT HOME TRACTS, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, more particularly described as follows:
