MEDUNA, ROBERT & LINDA WEAVER (HUSBAND & WIFE) AND RAYMOND & DARREL MEDUNA (HUSBAND & WIFE), hereinafter called grantees, does hereby grant, bargain, sell and convey unto the grantees, not as tenants in common but with the right of survivorship, their assigns and the heirs of the survivor of the grantees, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in KLAMATH County, State of Oregon, described as follows, to-wit:

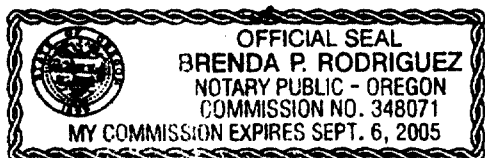
