hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto _____

property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in _____
Klamath County, State of Oregon, described as follows, to-wit:

That portion of Lot 8, Block 5, Supplemental Plat of Nichols Addition To City of Klamath Falls, Oregon, not included within the right-of-way
of the Government Irrigation Canal running through said lot, according to the plats of said Addition on file and of record in the office of
the County Clerk of Klamath County, Oregon.

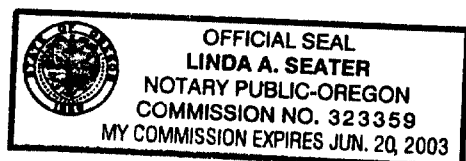
