QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon
hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto _____
Edward P. O'Neill
hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real
property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in _____
Klamath County, Sate of Oregon, described as follows, to-wit:

Commencing at the Northwest corner of Block 41, Supplemental Plat of Nichols Additon To City of Klamath Falls, Oregon, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon; thence running in a Southerly direction along the Westerly line of said Block 41, 80' for a point of beginning; thence in an Easterly direction and at right angles to Sixth Street, 130'; thence in a Southerly direction and parallel to Sixth Street 40'; thence in a Westerly direction and parallel to the first course herein described, 130' to Sixth Street; thence in a Northerly direction along the line of Sixth Street, 40' to the place of beginning, in the County of Klamath, Street of Oregon.
