QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon  
hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Tyra Lynne Justice  
hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real  
property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath  
County, State of Oregon, described as follows, to-wit:

Parcel 1: Lots 5 and 6, Block 1, Fairfield, according to the official plat thereof on file in the office of the County Clerk of Klamath  
County, Oregon.

Parcel 2: A portion of Lot 1, Block 1, Fairfield, described as follows: Beginning at a point on the North line of said Lot 1, Block 1,  
Fairfield, which point is 118' East of the NW corner of said Lot 1; thence South and parallel with the E line of said Lot 1, 48' to the South  
line of said Lot 1; thence East along the South line of said Lot 1 to the Southeast corner of said Lot 1; thence North on the East line of  
said Lot 1, 48' to the Northeast corner of said Lot 1; thence West on the North line of said Lot 1 to the point of beginning.

Parcel 3: All that portion of Lot 2, Block 1, Fairfield, lying East of the East line of Lots 3 and 4 of said Block 1 extended North across  
said Lot 2. The property herein described having a width East and West of 120' measured on the South line thereof.

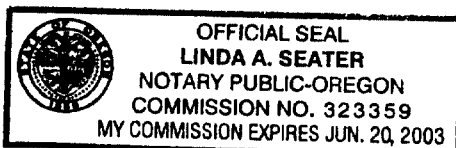
