QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon  
hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Paul Anthony Sabesky  
hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real  
property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath  
County, State of Oregon, described as follows, to-wit:

A portion of Lot 55, Block 6, Oregon Pines, according to the official plat thereof on file in the office of the County Clerk of Kl Co, OR, more  
particularly described as follows: Beginning at the Southwesterly corner of Lot 5 of said Block 6; thence N 72° 17' 07" W to the Easterly  
line of Section 16, 425.31 feet; thence N 00° 51' 27" E, along the Easterly line of Section 16, 276.71'; thence S 64° 36' 32" E, 548.48',  
to the Northwesterly corner of Lot 5; thence S 28° 56' 22" W, 195.29', along the Westerly line of Lot 5 to the point of beginning.

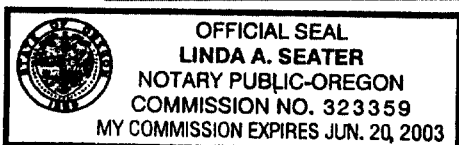
