The true and actual consideration of the transfer, set forth in said Land Sale Agreement is \$9,000.00, all deferred payments bear interest at the rate of 10% per annum from the date of said Land Sale Agreement until paid.

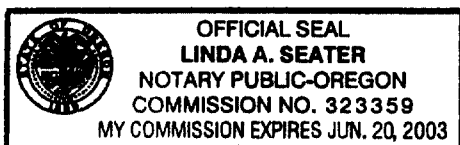
