In Witness Whereof the said vendor has executed this Memorandum May 14, 2003.

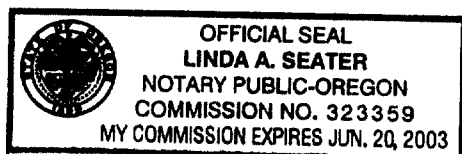
