
APPOINTMENT OF SUCCESSOR TRUSTEE

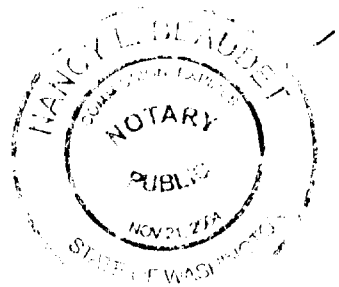
